3. Interested bidders may obtain further information from and inspect the Bidding Documents at *the address stated above.*
4. A complete set of Bidding Documents may be acquired by interested bidders on **3 February 2025** from the *address stated above.*

5. Prospective bidders shall submit their duly accomplished forms as specified in the Bid Documents in two (2) separate sealed bid envelopes to the BAC Chairperson. The first envelope shall contain the technical component of the bid, which shall include the eligibility requirements. The second envelope shall contain the financial component of the bid. Contract will be awarded to the Lowest Calculated Responsive Bid as Determined in the bid evaluation and the post-qualification. Bids will be opened in the presence of the Bidders' or their representatives who choose to attend at the aforementioned address. Eligibility Documents and Bid proposals submitted after the deadline shall not be accepted.
6. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.
7. *AEC* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
