


MSRD-SRD-005-2025 Late Filing of 2024 3rd Quarterly Report

Gentlemen:

This refers to **ANGELES ELECTRIC CORPORATION**'s (the "Company") 3rd Quarter Report (SEC Form 17-Q) for the period ended 30 September 2024¹, which was filed with the Commission on 15 November 2024.

Pertinent to the filing of SEC Form 17-Q are Rules 17.1.1.1 and 17.1.1.1.2 of 2015 Implementing Rules and Regulations of the Securities Regulation Code ("SRC IRR"), which provides:

"17.1.1.1. The public and reporting companies shall file with the Commission:

17.1.1.1.2. A quarterly report on SEC Form 17-Q **within forty-five (45) calendar days** after the end of each of the first three quarters of each fiscal year. xxx" (Emphasis supplied)

In this regard, the Company is hereby directed to show cause **within five (5) business days** from actual receipt of an email or hard copy of this letter, whichever is earlier, why it should not be held liable for late filing of the subject SEC Form 17-Q, in violation of Rule 17.1.1.1.2 of the 2015 SRC IRR.

Failure of the Company to file its written explanation (together with supporting documents, if applicable) within the said period shall be construed as a waiver of the Company's right to be heard and allow this Department to rule on the case based on the available information.

Finally, it is emphasized that this letter is without prejudice to the prerogative of this Department to act later against **ANGELES ELECTRIC CORPORATION**, or any other person to enforce the provisions of the RCC, Securities Regulation Code and its implementing rules and regulations, and other pertinent laws, rules and regulations, as may be necessary and applicable under the circumstances.
